Lakshmi Narayanan, Director, (hereinafter referred to as "Second Party", company which expression, unless excluded by or repugnant to the subject or context shall include its successors - in-office, administrators and assigns). (First Party and Second Party are hereinafter jointly referred to as 'Parties' and individually as 'Party') as

#### WHEREAS:

- A) First Party is a higher educational institution named:

  JANSONS SCHOOL OF BUSINESS (AUTONOMOUS), COIMBATORE
- B) First Party & Second Party believe that collaboration and cooperation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.

- D) Both Parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interests.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:

#### CLAUSE 1

#### **CO-OPERATION**

- 1.1 Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the Institution and its related wings. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.
- 1.2 The general terms of co-operation shall be governed by this MOU.

#### **CLAUSE 2**

## **SCOPE OF THE MOU**

- 2.1 Both Parties believe that close co-operation between them would be of major benefit to the student community and industry participants, to enhance their skills and knowledge.
- 2.2 The **BUSINESS RELATIONS UNIT (BRU)** of JSB intends to conduct the following activities from the year 2020.
  - 1. THE UNDERMENTIONED ACTIVITIES ARE FOR JSB STUDENTS ONLY:
    - Conduct of Certificate Course in "Employability and Ownership Quotient".
    - Business Plan Competition.
  - 2. CONDUCTING MANAGEMENT DEVELOPMENT PROGRAMME IN WORKING CAPITAL MANAGEMENT FOR ALL BUSINESS
  - 3. CONDUCTING CLUSTER BASED MANAGEMENT DEVELOPMENT PROGRAMME (MDP WILL BE DESIGNED BASED ON THEIR NEED)

- 2.3 Second Party will give valuable inputs to the First Party in teaching / training methodology and suitably customize the curriculum so that the students fit into the industrial scenario meaningfully.
- 2.4 Both Parties to obtain all internal approvals, consents, permissions, and licenses of whatsoever nature required for offering the Courses on the terms specified herein
- 2.5 There is no financial commitment on the part of the JANSONS SCHOOL OF BUSINESS (AUTONOMOUS), COIMBATORE the First Party, to take up any courses mentioned in the MOU. If there is any financial consideration, it will be dealt with separately.

## **CLAUSE 3**

## **VALIDITY**

- This agreement will be valid until it is expressly terminated by either Party on mutually agreed terms.
- 3.2 Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of termination, both parties have to discharge their obligations duly.

## CLAUSE 4

## RELATIONSHIP BETWEEN THE PARTIES

4.1 It is expressly agreed that **First Party** and **Second Party** are acting under this MCU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership.
